The test of raw materials shall be carried out as per the relevant IS code. The plant from which supply of material is done shall be approved by Engineer in charge prior to procurement.

The Contractor to execute design and concept as decided by the architect and engineer in charge and the quote should be included with the wastage cost as overhead in the tender. Patterns for woodwork and cutting work shall be as per the instructions of architects.

Wherever scaffolding/ ladders are necessary shall be provided by Contractor, it shall be erected on double supports tied together by horizontal pieces, over which scaffolding planks shall be fixed. Necessary safety precaution shall be taken with provision of safety harness/belt attached to the fixed and stable structure.

Arrangement of temporary power supply to carry out the work is in the scope of contractor.

The quantity of items is tentative it may vary to any extent.

Safety barricading/Safety Tape shall be provided by Contractor.

Transportation of materials from the factory to ACTREC installation site respectively, unloading, keeping the same at site appropriately and placing as per the instructions of Engineer-in-charge.

Disposal /Removal of material should be done as mentioned in the item rates and as per the instruction of Engineer-in charge and final bill will be released after clearance of site.

During works, all furniture, Equipment's, lighting, fixtures, sanitary fittings, glazing, floors etc. shall be protected by tarpaulin cover and stains, smears, splashing if any shall be removed and any damage done shall be made good by the contractor at free of cost.

After completion of entire work, the area shall be kept clean and cleared from debris. After painting, flooring etc. shall be cleaned by using water/ acid wash for removal of painting stains drops etc.

The proposed works is to be carried out at ACTREC, Kharghar
