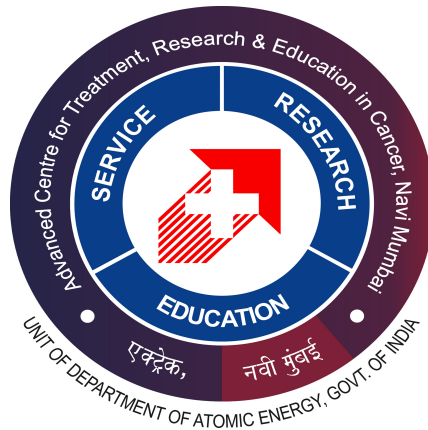

3. Bidder must note that any banned items will not be allowed inside the campus.
4. Tenders which are received late will not be considered and will be rejected.
5. The tender shall be valid for 180 days from the date of opening of the tender.

The bill shall be submitted for each calendar month duly completed in all respect by 7th of succeeding month so as to enable the ACTREC for arranging payment at the earliest possible. The bill will be supported by a statement showing the details of date wise supply of chicken. The payment to the contractor shall be made by ACTREC through NEFT/RTGS within 30 days from the date of receipt of the bill verified/certified by CFSD department and the contract shall not be entitled to claim any interest delay in payment due to unforeseen reasons.
29. Rate should be as per Kg as specified in the Annexure I (Financial Bid) for the item the standard monthly average consumption will vary.
30. Poultry meat must be intact even during transportation, food handling and storage.
31. Quality and quantity of the material will be checked and approved by the designated authorities of the Centre.
32. Poultry meat should always be supplied along with an appropriate Challan/Invoice.
