5	EXAMS	Candidates must score at least 50% in each individual theory and practical examination of the course to be considered successful.
6	Terms and Conditions	A trainee who fails to complete the training, will be liable to pay to the Institute(TMC-ACTREC) a sum equivalent to aggregate amount of stipend received by him/her during the period of training along with interest thereon.

Outstation candidate may be provided accommodation (Subject to availability) during the training period. They will have to pay accommodation charges as per institute policy.

Terms & Condition:

During the period of training, the trainee shall not apply for any other course/PG studies/scholarship or appear for any examination or interview outside without the permission of the center.

Any trainee leaving or remaining absent from the training before completion of this course will have to refund the amount of stipend together with interest thereon as per the rates fixed by the center. candidates whose performance in the course work is consistently found below expected standards will be terminated from the training course.

If more than 30 candidates apply for this position, a written examination will be conducted and the short listed candidates will be interviewed. Candidates will be selected based on performance in the interview.

Person working under central / State government, Autonomous body, Semi Government organizations and other public sector undertaking must submit no objection certificate from their present employer. ACTREC reserves the right to restrict the number of candidates for the interview to a reasonable limit on basis of qualification and marks. Merely fulfilling prescribed qualification will not entitle an applicant for the interview. TMC ACTREC also reserve the right to reject any of the applications without assigning any reason thereof.
