ADVANCED TRAINING COURSE IN PULMONARY FUNCTION TESTING

Tata Memorial Centre, ACTREC, is offering a certificate course in Pulmonary Function Testing. This course will cover both theoretical and practical aspects, including hands-on training in Pulmonary Function Testing. A certificate will be awarded to candidates who successfully complete the course.

1	DURATION	Course commencing from 02.02.2026 [6 months Training + 6 months Mandatory Internship]
2	QUALIFICATIONS	BSc/Diploma Respiratory Therapy/Respiratory Technology/Medical technology/Paramedical technology/Allied health sciences/ Graduate in any field with 6 months experience in healthcare industry
3	AGE LIMIT	Up to 40 years as on Last Date of Application (Relaxable for sponsored candidates and SC/ST & OBC as per rules)
4	NO. OF SEATS	1 (One seat)
5	STIPEND	Rs.8000/- during first 6months of training, Rs.12000/- during 6months of internship. A trainee who fails to complete the training, will be liable to pay to the Institute(TMC-ACTREC) a sum equivalent to aggregate amount of stipend received by him/her during the period of training along with interest thereon.

DETAILS OF THE COURSE:

1	COURSE FEES (NON-REFUNDABLE)	Rs.. 12000/- +18% GST
2	DURATION OF THE COURSE	1 Year Commencing from 1 st August 2025 (6 months of training and 6 months of internship)
3	STRUCTURE OF THE COURSE	Posting in PFT Lab, ACTREC for training in performing and reporting Spirometry, Body Plethysmography, DLCO, and 6MWT.

4	OBJECTIVES	At the end of the course, the student would be able to independently perform and report Pulmonary Function Tests. Work as a Full-time PFT Technician in hospitals/Clinics/ Medical Colleges.
5	EXIT EXAMS	Candidates must score at least 50% in each individual theory and practical examination of the course to be considered successful.

Outstation candidate may be provided accommodation (Subject to availability) during the training period. They will have to pay accommodation charges as per institute policy.

Terms & Condition :

During the period of training, the trainee shall not apply for any other course/PG studies/scholarship or appear for any examination or interview outside without the permission of the center.

Any trainee leaving or remaining absent from the training before completion of this course will have to refund the amount of stipend together with interest thereon as per the rates fixed by the center. candidates whose performance in the course work is consistently found below expected standards will be terminated from the training course.

If more than 30 candidates apply for this position, a written examination will be conducted and the short listed candidates will be interviewed. Candidates will be selected based on performance in the interview.

Person working under central / State government, Autonomous body, Semi Government organizations and other public sector undertaking must submit no objection certificate from their present employer. Actrec reserves the right to restrict the number of candidates for the interview to a reasonable limit on basis of qualification and marks. Merely fulfilling prescribed qualification will not entitle an applicant for the interview. TMC ACTREC also reserve the right to reject any of the applications without assigning any reason thereof.
